The World Leaders In The Security Token Ecosystem

DUBLIN, LUXEMBOURG, MUNICH, VIENNA - **For the second time, the Austrian Blockchain Center and Black Manta Capital Partners published THE TOKENIZATION 50, the most up-to-date overview of the global security token ecosystem, this year presented at Blockchain Ireland Week in Dublin.**

The Austrian Blockchain Center, an interdisciplinary research institute focused on blockchain and related technologies and Black Manta Capital Partners, the European Union's first fully licensed specialist broker for digital securities, teamed up again to conduct an in-depth analysis of the state of the regulated digital assets market, its key players, and upcoming trends in the tokenization of securities.

The first findings and the 2022 ecosystem map were presented to Blockchain Ireland Week. Based on a comprehensive market screening and an online survey among dozens of international market leaders, The Tokenization 50 provides an up-to-date overview of the leading companies in the global security token ecosystem in 2022. In addition to some changes in the enterprise space, our results highlight the trend towards a multichain environment wherein other layer-1 blockchains, such as Avalanche, Tezos, and Algorand are gaining market share over Ethereum.
