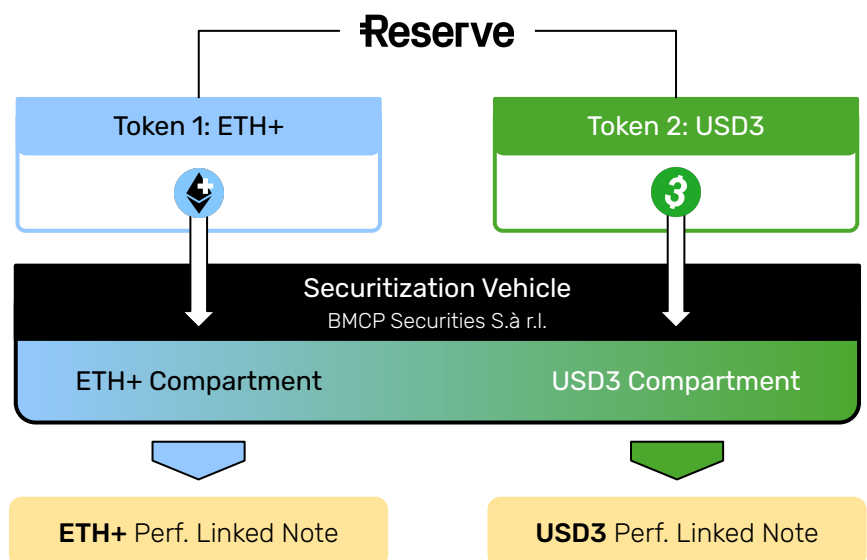
Products Overview

Modern Yield, Classic Structure: DeFi Inside a Regulated Wrapper

Structured as PLNs, they aim to closely mirror the returns generated by the underlying **ETH+** and **USD3** Tokens, allowing investors to unlock Ethereum staking yield & DeFi yield respectively, through a familiar security while preserving the characteristics of the underlying crypto-native asset.



To support institutional access and regulatory compliance, the offering leverages Black Manta Capital Partners Luxembourgish securitization vehicle. Through this structure, dedicated compartments are created within the vehicle, allowing for the issuance of securities with a unique ISIN.
