## Solar Power Meets Digital Investment: Tokenized Renewable Bonds by Vindo Solar are now available for pre-registration on Black Manta Capital Partners, in Partnership with Penomo

MUNICH, AMSTERDAM, 19. September 2025 - **Black Manta Capital Partners ("BMCP"), a MiFID II-licensed next-generation investment firm, and Vindo Solar, a leading solar development and engineering, procurement, and construction (EPC) company, today announced the launch of a tokenized solar bond. The 600,000 EUR offering will support the execution of a signed contract for a German solar PV project, showcasing the application of regulated digital finance to real-world infrastructure. This offering marks a significant step in making sustainable energy infrastructure accessible to investors through digital finance.**

This collaboration with Vindo Solar aligns with BMCP's vision of unlocking new levels of liquidity, confidence, and security for investors by bringing more and more alternative real-world assets into a digital framework. The transaction is the first in a multi-million-euro pipeline of renewable assets to be tokenized, further solidifying the role of tokenization in modern capital markets.

The issuance aims to provide institutional investors and sustainability-oriented allocators with a fixed-yield opportunity in renewable energy deployment. The tokenized bond provides a short-duration, six-month working capital investment for a solar PV project in Großglattbach, Germany. Funds from the investment will be allocated to supplier prepayments, project execution, and site mobilization to prepare for the construction period of September 2025 to January 2026. The project is estimated to produce over 10 GWh annually, contributing to approximately 7,000 tons of CO<sub>2</sub> savings per year.

The partnership highlights BMCP's deep expertise in every technical, financial, and legal aspect of asset and security tokenization. Supporting the collaboration, Penomo acts as
